**ORDER REINSTATING RESPONDENT  
TO ACTIVE STATUS**


On November 10, 2010 and November 23, 2010, respondent Duane R. Folke filed a motion and amended motion, respectively, to reinstate respondent to active status. On November 30, 2010, the Office of Probation by Supervising Attorney Terrie Goldade, filed opposition contending, inter alia, that not all the amounts due in respondent's restitution obligation in Supreme Court order S166504 had been paid. Since respondent's suspension contained a provision requiring him to remain suspended until all restitution was paid, the Office of Probation contended that his return to active status was premature. On December 10, 2010, respondent filed a reply to the opposition.

On December 21, 2010, the court held a telephonic status conference during which the parties discussed the amounts that needed to be paid and the proof that needed to be provided to the Office of Probation to justify respondent's reinstatement. On December 22, 2010, the court was informed that respondent had paid the amounts required and produced the required proof. As such, **GOOD CAUSE APPEARING THEREFOR**, and provided he has satisfied all other

requirements imposed upon him by the State Bar of California, respondent Duane R. Folke is ordered **REINSTATED TO ACTIVE STATUS**, effective as of the date of this order.


