MODIFICATION ORDER

The Order Approving Stipulation Re Facts and Conclusions of Law ("Stipulation") executed on October 15, 2004, is hereby MODIFIED, sua sponte, to include the following modifications:

1. On page 11 of the Stipulation, footnote 1, line 4, "Tony Plascentia" is deleted and in its place is inserted "Tanya Plascentia."¹

2. On page 11 of the Stipulation, footnote 1, line 7, "Enriqueto Branch" is deleted and in its place is inserted "Enrigueta Branch."

3. On page 13 of the Stipulation, under the heading "Waivers re: Restitution," all references under paragraph (3) to "rule 805" are deleted and replaced by "rule 806."

4. On page 13 of the Stipulation, under the heading "Waivers re: Restitution," in the first bullet point paragraph, "herein" is deleted and in its place is inserted "in the Amended Contract and Waiver for Participation in the State Bar Court's Alternative Discipline Program or as determined

1 by fee arbitration.”

2 5. On pages 13-14 of the Stipulation, all language under the heading “Restitution Amounts”
3 is deleted as restitution and fee arbitration provisions will be set forth in the Amended Contract and
4 Waiver for Participation in the State Bar Court’s Program for Respondents with Substance Abuse
5 or Mental Health Issues.

6 6. On page 14 of the Stipulation, all language under the heading, “Compliance with
7 Underlying Court Orders” is deleted as these matters will be addressed in the Amended Contract and
8 Waiver for Participation in the State Bar Court’s Program for Respondents with Substance Abuse
9 or Mental Health Issues.

10 Any objection to this modification order must be filed within 15 days of its service. If no
11 timely objection is filed, the stipulation as modified remains approved, and a staff member of the
12 State Bar Court is directed to transmit the record in this matter to the Supreme Court without further
13 delay.
