On October 9, 2009, the Office of Probation of the State Bar of California filed a response proposing a simplified version of the suggested modification. The court finds good cause to grant the modification, as set forth in the response of the Office of Probation. As such, probation is modified as follows:

1. Respondent's minimum monthly payment is ordered increased to \$400.00; and
2. The deadline for completion of all restitution is extended from September 30, 2009 to September 30, 2010.
