13 The Order Approving Stipulation Re Facts, Conclusions of Law and Disposition filed on July
14 30, 2003, is hereby MODIFIED, sua sponte, to include the following modifications:

15 1. On page 1 of the stipulation, paragraph A.(7), "2004" is deleted and in its place is inserted
16 "2005."

17 2. On page 5 of the stipulation, paragraph E.(7), the "x" in the box next to "No Ethics School
18 recommended See Attachment as [sic] Page 6" is deleted and an "x" is inserted in the box next
19 to the language requiring Respondent to attend Ethics School. The language of the parties at page
20 6 of the stipulation does not set forth sufficient cause to exclude Respondent from having to attend
21 State Bar Ethics School as required by rule 290 of the Rules of Procedure of the State Bar of
22 California.

23 3. On page 7 of the stipulation, in the caption, "Kirhill" is deleted and in its place is inserted
24 "Kurkhill."

25 4. On page 7 of the stipulation, paragraph a., the requirement that Respondent pay restitution
26 to Christopher Northcutt is deleted in its entirety, as it appears that Respondent has already paid
27 restitution to Mr. Northcutt.

28 Any objection to this modification order must be filed within 15 days of its service. If no



1 timely objection is filed, the stipulation as modified remains approved, and a staff member of the
2 State Bar Court is directed to transmit the record in this matter to the Supreme Court without further
3 delay.


