**MODIFICATION ORDER**

The Order Approving Stipulation Re Facts, Conclusions of Law and Disposition filed on August 2, 2002, is hereby MODIFIED, sua sponte, to include the following modifications:

1. On page 4 of the stipulation, paragraph D.3.A.ii., "December 2001" is deleted and in its place is inserted "December 1, 2001."
2. On page 6 of the stipulation, at paragraph a., the check marks in the boxes are deleted.
3. On page 7 of the stipulation, "ET AL." next to Case No. 02-O-10064 is deleted.
4. On page 8 of the stipulation, the heading "Financial Conditions, Restitution" and all language of the paragraph following said heading is deleted, as Respondent will remain actually suspended until she pays restitution and provides proof thereof (see page 4 of the stipulation, paragraph D.3.).
5. The Court's Modification to Stipulated Facts, Conclusions of Law and Disposition dated August 1, 2002, which was attached to the Court's Order Approving Stipulation is also deleted.

Any objection to this modification order must be filed within 15 days of its service. If no timely objection is filed, the stipulation as modified remains approved, and a staff member of the State Bar Court is directed to transmit the record in this matter to the Supreme Court without further


