On February 10, 2006, the State Bar Office of the Chief Trial Counsel, by Deputy Trial Counsel Diane J. Meyers, timely filed a motion to withdraw (as to level of discipline) or modify the stipulation in this matter. The grounds for the motion to withdraw the stipulation are that respondent failed to attend Ethics School as set forth in the stipulation on several occasions, ending in her failure to attend on February 9, 2006, the day after the stipulation was signed.

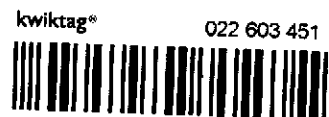
The grounds for the motion to modify are that the court modified the stipulation to reflect the parties original agreement to exclude a violation of Business and Professions Code section 6106, but failed to consider the parties' subsequent agreement to add that charge back into the stipulation. DTC Meyers duly notified the court of that subsequent agreement on November 10, 2005.

No opposition to this motion was filed by respondent.

The court has considered the moving papers, the stipulation, and all other documents filed in this action. The motion to withdraw the stipulation as to level of discipline is **DENIED**. The motion to modify by reinstating the Business and Professions Code section 6106 charge located at page 11, paragraph 11 that was stricken in the court's modification of the stipulation filed February 9, 2006 is **GRANTED**. The modification in the court's February 9, 2006 order approving the

stipulation is hereby removed, and by this order, the Stipulation is approved and the discipline recommended to the Supreme Court as agreed to by the parties.


