TO ALL PARTIES AND COUNSEL IN THE ABOVE ENTITLED MATTER:

On March 26, 2010, petitioner **George Hall Dunlap**, **Jr.**, through his counsel Pamela K. Dunlap, sought a rehearing of his motion for request for relief from or extension of time to pay disciplinary costs, including his reply to the State Bar's opposition. (Supreme Court case No. S169935, effective April 17, 2009.)

The State Bar did not file a response to the motion for rehearing.

On March 4, 2010, the court had denied petitioner's initial request for cost relief because no good cause was shown. However, in his motion for rehearing, petitioner has submitted additional evidentiary evidence regarding his medical condition, finance and expenses in support of his claim of financial hardship.



ACCORDINGLY, in view of petitioner's financial hardship and good cause appearing, the court has reconsidered petitioner's request and hereby **GRANTS** his motion for extension of time to pay disciplinary costs.

The court **ORDERS** that respondent's time during which to pay the disciplinary costs be extended to two equal installments: one-half of said costs be paid with membership fees for the years 2011 and 2012. It is further ordered that if respondent fails to pay any installment within the time provided herein or as may be modified by the State Bar Court pursuant to Business and Professions Code section 6086.10, subdivision (c), the remaining balance of the costs is due and enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.

IT IS SO ORDERED.
