ORDER GRANTING MOTIONS FOR EXTENSION OF TIME TO PAY COSTS AND TO EXTEND PROBATION IN ORDER TO PAY RESTITUTION

On November 19, 2007, respondent Zakeya Leona Brookins, filed a motion to extend her probation in order to pay restitution and a motion to extend the time to pay costs arising out of disciplinary proceedings. On December 5, 2007, respondent filed a supplemental declaration in support of her motion to extend probation.

On November 21, 2007, the Office of the Chief Trial Counsel of the State Bar of California, by Deputy Trial Counsel Eli D. Morgenstern, filed a response to the motion to extend time to pay costs, indicating no opposition to an extension to pay up to and including June 15, 2008. On November 29, 2007, the Office of Probation of the State Bar of California, by Supervising Trial Counsel Terrie Goldade, filed a response, indicating no opposition to extending probation.

GOOD CAUSE APPEARING THEREFOR, respondent's time for paying disciplinary costs is ordered extended to June 15, 2008, and the period of her probation is extended by an additional three years.

IT IS FURTHER ORDERED that respondent is to make minimum payments of at least \$100 per month, payable first to the individual payees to whom she owes restitution, and then, when ///

such individual payees are fully paid, to the Client Security Fund.

Service of this order shall be upon both the Office of the Chief Trial Counsel and the Office of Probation of the State Bar of California.

ORDER EXTENDING TIME FOR PAYMENT OF RESTITUTION

On June 20, 2007, this court vacated an order granting an extension of time to pay restitution, on the grounds that the court had acted prematurely in issuing its underlying order; that is, it filed its order after the Office of the Chief Trial Counsel had responded, but had not waited until the Office of Probation had filed its response. In the June 20, 2007 order, the court ordered probation to file a response to the request for extension. On June 21, the Office of Probation filed its response, indicating no opposition to the requested extension of time.

GOOD CAUSE APPEARING THEREFOR, the May 1, 2007 motion of respondent is GRANTED and the time within which respondent Zakeya Leona Brookins must pay the restitution charges in this matter is extended to November 15, 2007, five days before the date the probation period ends.
