ORDER GRANTING MOTION FOR EXTENSION OF TIME TO PAY DISCIPLINARY COSTS

On July 26, 2005, respondent Zakeya Leona Brookins, filed a motion for extension of time
to pay disciplinary costs. On August 4, respondent filed a supplement to that motion. On August
15, 2005, the Office of the Chief Trial Counsel, by Deputy Trial Counsel Eli D. Morgenstern, filed
a response to the motion, indicating that the Office of the Chief Trial Counsel took no position as
to whether or not the motion should be granted.

Again on September 1, 2006, respondent filed a motion for an extension of time to pay
 disciplinary costs on the grounds of financial hardship. DTC Morgenstern of the Office of the Chief
 Trial Counsel filed a response, again indicating no opposition.

Based on the papers filed in this action, and good cause appearing therefor, the motion for
an extension of time to pay disciplinary costs is granted. Respondent must pay all outstanding
disciplinary costs on or before May 1, 2007.
