On October 29, 2010, respondent Pamela G. Lacher filed a motion seeking an extension of time in which to provide proof of passage of the Multistate Professional Responsibility Examination (MPRE). She unsuccessfully took the August 2010 offering of the MPRE and has registered to take the November 6, 2010 MPRE. Respondent requests that she be given an extension until after the release of the results of the November 6, 2010 MPRE; and in the event that she does not pass the November 2010 MPRE, that she be given an extension to take the March 2011 MPRE and to provide proof of the results of that examination.

On November 3, 2010, the Office of Probation, by Terrie D. Goldade, filed a non-opposition response to respondent's request for an extension of time to provide proof of passage of the MPRE to one week after the release of the results of the November 6, 2010 MPRE. However, the Office of Probation opposes an extension of time for respondent to take the March 2011 MPRE and provide proof of the results of that examination.


Having considered the parties' contentions and good cause appearing and in interests of judicial economy, the court **ORDERS** that the time in which respondent must successfully

complete the MPRE is extended until the results of the November 2010 MPRE are released. Respondent must provide satisfactory proof of having taken the November MPRE to the Office of Probation no later than 10 days after the results of the MPRE are received or December 23, 2010, whichever is later.

In the event that respondent has taken, but has not successfully completed the November 6, 2010 MPRE and has provided proof thereof to the Office of Probation, IT IS FURTHER ORDERED that the time in which she must successfully complete the MPRE will be further extended until the results of the March 2011 MPRE are released. In that event respondent must take the March 2011 MPRE and provide satisfactory proof of the successful completion of that examination to the Office of Probation no later than 10 days after the results of the MPRE are received or April 30, 2011, whichever is later.

IT IS SO ORDERED.
