ORDER GRANTING MOTION
FOR CLARIFICATION &
MODIFYING DECISION

This matter is before the court on the State Bar's June 6, 2005 motion for clarification. The motion is GRANTED. The court's decision filed in this proceeding on May 5, 2005, is MODIFIED as follows: (1) on page 7, line 14, the reference to footnote number "12" is deleted; (2) at the bottom of page 7, footnote number 12 is deleted in its entirety; (3) on page 8, line 1, the reference to footnote number "11" is deleted; and (4) on page 15, line 6, the word "six" is deleted, and the word "four" is substituted in its place.¹

These modifications correct clerical errors and, therefore, do not extend the time in which the parties may seek reconsideration, within the State Bar Court, of the court's May 5, 2005 decision.
