On January 3, 2011, respondent Ruth Ellen Ratzlaff, who is representing herself in this matter, filed a motion to extend the time within which to take and pass the Multistate Professional Responsibility Examination (MPRE), a condition attached to her public reproof. The motion was supplemented on January 18 and 21, 2011. Respondent, who unsuccessfully took the March, August, and November 2010 offerings of the MPRE, has registered to take the March 5, 2011 MPRE.


On January 6, 2011, Terrie Goldade of the Office of Probation of the State Bar of California (State Bar) filed the State Bar's response in opposition to respondent's motion. Having considered the parties' contentions and good cause appearing, the court GRANTS the motion. Accordingly, IT IS ORDERED, that the time in which respondent must successfully complete the MPRE is extended until the results of the March 5, 2011 MPRE are released. Respondent must provide satisfactory proof of the successful completion of the MPRE to the



Office of Probation, no later than 10 days after the results of the March 5, 2011 MPRE are received, or by April 12, 2011, whichever is later.

IT IS SO ORDERED.
