ORDER GRANTING RESPONDENT'S MOTION FOR EXTENSION OF TIME TO PAY DISCIPLINARY COSTS; ORDER DENYING RESPONDENT'S MOTION FOR WAIVER OF SOME OR ALL DISCIPLINARY COSTS OR OTHER PAYMENTS

Introduction

This matter is before the court on respondent James Friend Jordan's February 3, 2010, motion for relief from or extension of time to pay or waiver of some or all disciplinary costs or other payments.
