MODIFICATION ORDER

The Order Approving Stipulation Re Facts, Conclusions of Law and Disposition (stipulation) filed on July 14, 2008, is hereby MODIFIED, sua sponte, to include the following modifications:

1. In the caption on page 1 of the stipulation, "PHYLLIS J. BRIAN" is deleted, and in its place is inserted "PHYLLIS J. BRYAN".
2. In the caption on page 1 of the stipulation, under respondent's information, "90201" is deleted, and in its place is inserted "90210".
3. On page 5 of the stipulation, the "x" in the box next to paragraph E.(1) recommending respondent's conditional compliance with standard 1.4(c)(ii) is deleted, as respondent's period of actual suspension is less than two years.

Any objection to this modification order must be filed within 15 days of its service. If no timely objection is filed, the stipulation as modified remains approved, and a staff member of the State Bar Court is directed to transmit the record in this matter to the Supreme Court without further delay.
