**ORDER VACATING ORDER APPROVING  
STIPULATION FILED JANUARY 14, 2008;  
ORDER APPROVING STIPULATION**

On January 14, 2008, the court filed an order approving a stipulation re facts, conclusions of law and disposition in the above-entitled matter. At the time the parties presented the stipulation to the court for approval, however, the parties attached the incorrect order form which was inadvertently executed by the court. Therefore, the court's January 14, 2008, order is hereby vacated, and the court now renders the following order:

Finding the stipulation to be fair to the parties and that it adequately protects the public, IT IS ORDERED that the stipulated facts and disposition are APPROVED AS MODIFIED as set forth below, and the DISCIPLINE IS RECOMMENDED to the Supreme Court.

1. On page one of the stipulation, in the box entitled In Pro Per Respondent, "Bar #171057" is deleted and in its place is inserted "Bar #171037."

The parties are bound by the stipulation as approved unless: 1) a motion to withdraw or modify the stipulation, filed within 15 days after service of this order, is granted; or 2) this court further modifies the approved stipulation. (See rule 135(b), Rules of Procedure.) **The effective date of this disposition is the effective date of the Supreme Court order herein, normally 30 days after file date. (See rule 9.18(a), California Rules of Court.)**


