**MODIFICATION OF OPINION
ON REVIEW**

On our own motion, our opinion filed October 26, 2006 is modified to include provisions inadvertently omitted, by adding the following text to the end of page 6 of the opinion:

“We further recommend that, within one year after the effective date of the Supreme Court’s order, respondent provide to the State Bar’s Office of Probation, satisfactory proof of attendance at six hours of the remedial legal ethics course and on the terms recommended on page eight of the hearing judge’s order granting motion to revoke probation herein, filed May 11, 2005.

We further recommend that respondent be ordered to take and pass the Multistate Professional Responsibility Examination administered by the National Conference of Bar Examiners prior to the expiration of his period of actual suspension and to provide satisfactory proof of such passage to the State Bar’s Office of Probation in Los Angeles within the same period.


Finally, we do not vacate the hearing judge's order of inactive enrollment (Bus. & Prof. Code, § 6007, subd. (d)(1)), which has remained in effect since May 14, 2005, but credit toward the period of actual suspension is given for the period of involuntary inactive enrollment.”


