OPINION

On our own motion, our typescript opinion filed July 17, 2008, is modified as follows:
On page 24, we delete the first paragraph and replace it with "We further recommend that respondent be ordered to take and pass the Multistate Professional Responsibility Examination administered by the National Conference of Bar Examiners during the period of actual suspension and to provide satisfactory proof of such passage to the State Bar's Office of Probation in Los Angeles within the same period. However, if the Supreme Court orders respondent to take and pass the Multistate Professional Responsibility Examination in *Williams I*, it is not recommended that respondent take and pass the Multistate Professional Responsibility Examination in connection with this matter."

On page 24, we delete the second paragraph and replace it with "For the reasons expressed in this opinion respondent's involuntary inactive enrollment effective July 21, 2007, and imposed under the provisions of Business and Professions Code section 6007, subdivision (c)(4) is hereby terminated. This termination order is effective the date this opinion is filed."

These modifications are deemed substantive changes in the review department's opinion.



Accordingly, the time for filing a request for reconsideration of the review department's opinion filed July 17, 2008, will be calculated from the date this order is served on the parties in accordance with rule 309(a) of the Rules of Procedure of the State Bar of California.


