A Member of the State Bar.

On July 8, 2010, respondent filed the following pleadings: 1) motion to vacate interim suspension and dismiss the matter or to stay interim suspension; 2) request for judicial notice of out-of-state decisions; 3) request for judicial notice of court documents; and 4) motion to seal protected material. On July 19, 2010, the State Bar filed its opposition to the motions.

Finding no good cause, the motion to vacate interim suspension and dismiss the matter is denied. Finding good cause, the motion to stay the interim suspension order filed on June 11, 2010, is granted and the suspension is stayed pending further order of this court.

Finding good cause, the request for judicial notice of out-of-state decisions is granted.

Finding good cause, the request for judicial notice of court documents is granted as to attachments 1 through 8. The request is denied as to attachments 9 through 12.

Finding good cause, the motion to seal protected material is granted only as to the following attachments to respondent's July 8, 2010, request for judicial notice of court documents: Attachments 3, 5, and 6. Finding no good cause, the motion to seal the remaining attachments is denied. This order applies only to the documents filed with the review department with this motion and has no effect on any documents filed in the hearing department.
