Respondent's Motion for Relief From or Extension of Time to Pay Disciplinary Costs


On July 1, 2011, Respondent filed a motion for relief from the Supreme Court's order assessing costs. On July 5, 2011, the State Bar filed its response to the motion, objecting to complete relief being given but indicating that it did not object to a limited installment plan being ordered.

No good cause has been shown for granting complete relief from the Supreme Court's prior order of costs. To the extent that Respondent's motion seeks such complete relief, the motion is denied.

GOOD CAUSE has been shown for extending Respondent's obligation to pay costs. Accordingly, such costs will now be due and paid by Respondent as follows: \$1,000 must be paid with membership fees for the year 2012. The remaining balance of the outstanding costs must be paid with membership fees for year 2013. In the event Respondent fails to pay any payment and/or installment as described above, the remaining balance is due and payable immediately.


