On January 3, 2011, petitioner **Jeffrey Alan Nelson** sought an extension of time to comply with the order assessing disciplinary costs in State Bar Court Case No. 06-O-13190. (Rules Proc. of State Bar, rule 5.130(B).) Petitioner's motion was based on financial hardship.

On February 4, 2011, Deputy Trial Counsel Erica Dennings of the Office of the Chief Trial Counsel of the State Bar of California ("State Bar") filed a response. The State Bar does not oppose an extension of time to pay costs, but recommends a three-year extension, rather than the four-year extension requested by petitioner.


After reviewing the parties' pleadings, petitioner's motion for extension of time to comply with the order to pay disciplinary costs is **GRANTED**. The court orders that petitioner's time to pay the disciplinary costs associated with case no. 06-O-13190 be extended and that one-fourth of said costs is to be paid with petitioner's annual State Bar membership fees for the years 2012, 2013, 2014, and 2015. The court further **ORDERS** that, if petitioner fails to pay any installment of disciplinary costs within the time provided herein or as may be modified by the



State Bar Court pursuant to Business and Professions Code section 6086.10, subdivision (c), the remaining balance of the costs is due and payable immediately unless relief has been granted under the Rules of Procedure of the State Bar of California. (Rules Proc. of State Bar, rule 5.134.) The payment of costs remains enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.

**IT IS SO ORDERED.**


