ORDERS:

Respondent's Motion for Relief from or Extension of Time to Pay Costs

<u>X</u>GRANTED

This motion was filed by Respondent Susan Chapkis (Respondent) on August 16, 2010, seeking relief from the prior costs award in the captioned matter. On August 30, 2010, the State Bar filed a response to the motion. The response opposed the granting of relief from the cost award but stated that the State Bar did not oppose the court granting a three-year payment plan.

Respondent's moving papers and supporting documents present a compelling case for granting relief from a cost award based on financial and other hardship.

GOOD CAUSE having been shown, the motion for judicial relief from the prior cost award is GRANTED as follows:

Respondent must pay the \$4,294.55 in disciplinary costs imposed on her by the Supreme Court in this matter. The time for her to pay such costs is extended as follows: Beginning October 1, 2011, Respondent must pay a minimum of \$214.73 per calendar quarter for the following five years or until the entire \$4,294.55 is paid, whichever occurs earlier. These quarterly installment payments are due no later than the 10th day of each January, April, July, and October. (Thus, Respondent's first installment payment is due no later than October 10, 2011.). (Bus. & Prof. Code, § 6086.10, subd. (c); Rules Proc. of State Bar, rule 282.) Respondent must submit her payments directly to the State Bar's Membership Billing Office in San Francisco and she must promptly submit proof of each such payment to the State Bar's Office of Probation in Los Angeles. If Respondent fails to pay any installment payment during or before the 10-day period following its due date without the *prior written approval* of the State Bar's Office of Probation, the





remaining unpaid balance of the costs is due immediately and is enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.
