ORDER RE RESPONDENT'S REQUEST FOR MODIFICATION OF THE TERMS OF HIS PROBATION

On February 18, 2011, respondent Randall John Bobus filed a request to stay the terms and conditions of his disciplinary probation contained in State Bar Court case nos. 06-O-15379; 07-C-11768; 07-C-12132 (Cons.) ("the Decision"). This motion was based on the fact that respondent has been incarcerated in the Sonoma County Jail since January 8, 2011. His tentative release date is July 8, 2011.

On February 28, 2011, the Office of Probation of the State Bar of California ("Office of Probation") filed an opposition to respondent's motion.

After thorough consideration of the parties' moving papers, the court issues the following orders:

1. Good cause having been shown, respondent's request to stay the provision that requires him to obtain psychiatric or psychological help/treatment, found at pages 10-11 of the Decision, is **GRANTED**. The requirements of this provision are hereby stayed for the duration of respondent's incarceration at the Sonoma County Jail;



2. Good cause having been shown, respondent's request to stay the provision that requires him to furnish blood and/or urine samples to a licensed medical laboratory approved by the Office of Probation, found at page 11 of the Decision, is **GRANTED**. The requirements of this provision are hereby stayed for the duration of respondent's incarceration at the Sonoma County Jail;

3. Good cause having been shown, the time permitted for respondent to provide to the Office of Probation satisfactory proof of attendance at a session of the State Bar Ethics School, found at page 10 of the Decision, is extended to December 31, 2011;

4. Good cause having been shown, the time permitted for respondent to take and pass the Multistate Professional Responsibility Examination and provide satisfactory proof of such passage to the Office of Probation, found at page 11 of the Decision, is extended to December 31, 2011;

5. No good cause having been shown, respondent's request to stay the provision that requires him to submit written quarterly reports to the Office of Probation, found at page 10 of the Decision, is **DENIED**. Furthermore, all other conditions of probation reflected in the Decision, with the exception of those referenced above, remain in full force and effect; and

6. Respondent is **ORDERED** to notify the Office of Probation within 10 days of his release/termination from incarceration at the Sonoma County Jail.

IT IS SO ORDERED.
