This matter is before the court on **Michael George McKneely's** January 10, 2011 motion for extension of time to pay the disciplinary costs that were imposed on him under the Supreme Court's January 26, 2009 order in *In re Michael George McKneely on Discipline*, case number S168123 (State Bar Court case number 07-C-13666). On January 12, 2011, McKneely filed a supplemental declaration in support of his motion.

On January 13, 2011, the Office of the Chief Trial Counsel of the State Bar of California (hereafter State Bar) filed a response to McKneely's motion. In its response, the State Bar does not articulate any opposition to McKneely's motion.

McKneely has established grounds of hardship, special circumstances, and other good cause sufficient to grant him the short extension of time that he requests to pay the remaining \$1,765 that he owes in disciplinary costs.

ORDER

The court orders that Michael George McKneely's January 10, 2011 motion for extension of time to pay costs is GRANTED and that the time in which Michael George McKneely must pay the remaining \$1,765 balance of costs due under the Supreme Court's January 26, 2009 order in *In re Michael George McKneely on Discipline*, case number S168123 (State Bar Court case number 07-C-13666), is EXTENDED to and including June 1, 2011. (Bus. & Prof. Code, § 6086.10, subd. (c); Rules Proc. of State Bar, rule 5.130(B).) The costs remain enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.
