On February 6, 2013, this court issued an order obligating Respondent to pay costs in the captioned matter in three separate installments, due in 2014, 2015, and 2016. Respondent paid the costs owed in 2014.

On December 22, 2014, Respondent filed a motion seeking relief from the prior order(s) assessing costs in the above matter. More specifically, Respondent asks that this court either to grant complete relief from his obligations to pay costs in the above matters or, in the alternative, to delay for one year the obligation to make the final two annual installment payments. In support of his motion, Respondent provided a financial statement showing his present financial inability to pay the required costs.

On December 23, 2014, the State Bar filed a statement opposing the granting of complete relief but not opposing Respondent's request that the installment plan be delayed for one year.

GOOD CAUSE having been shown, the remaining two years of the installment plan set forth in this court's February 6, 2013 order is modified to delay for one year Respondent's obligation to make payments in 2015 and 2016. Hence, the costs previously owed in the membership year 2015 will now be due at the time that dues are owed for the membership year 2016 will now be due at the time that dues are owed for the membership year 2017.

If Respondent fails to pay either of the above installment payments more than 10 days after its due date without the prior written approval of the State Bar or the State Bar Court, the remaining unpaid balance of the costs is due immediately and is enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.

To the extent that Respondent has sought complete relief from his obligation to pay costs, that request is DENIED.

IT IS SO ORDERED.
