On September 17, 2012, respondent Christie Bara Mitchell-Guttman, by counsel Michael R. Locks, filed a motion for a 90-day extension of time to take and pass the Multistate Professional Responsibility Examination (MPRE) as ordered by the California Supreme Court in order S192798, filed August 31, 201, and effective on September 30, 2011. Pursuant to this order, respondent has one year from its effective date to do so.

Respondent has unsuccessfully attempted the MPRE twice and is registered for its next offering in November 2012. In the meantime, she has numerous court appearances and trials scheduled and has advised clients and the relevant court of her possible suspension due to not having passed the MPRE within one year of the effective date of discipline.

Accordingly, good cause appearing, the court GRANTS the motion for an extension of time to take and pass the MPRE until the results of the November 2012 MPRE are released. Respondent must provide satisfactory proof of the successful completion of the MPRE to the




