
The Order Approving Stipulation Re Facts, Conclusions of Law and Disposition (stipulation) filed on July 2, 2008, is hereby MODIFIED, sua sponte, to include the following modifications:

- The court recommends that costs be paid in this matter in equal amounts prior to February 1 for the following membership years: 2010, 2011, and 2012. Thus, on page 2 of the stipulation, paragraph A.(8), the language inserted by the parties: "Costs to be paid in equal amounts prior to February 1 for the following three (3) billing cycles following the effective date of Supreme Court order" is deleted, and in its place is inserted "2010, 2011, and 2012. It is further recommended that if Christina Marie McPherson fails to pay any installment of disciplinary costs within the time provided herein or as may be modified by the State Bar Court pursuant to section 6086.10, subdivision (c), the remaining balance of the costs is due and payable immediately unless relief has been granted under the Rules of Procedure of the State Bar of California (Rules Proc. of State Bar, rule 286.) The payment of costs is enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment."
- On page 4 of the stipulation, the 'X' in the box next to paragraph E.(1) recommending respondent's conditional compliance with standard 1.4(c)(ii) is deleted, as respondent period of actual suspension is less than two years.

3. On page 10 of the stipulation, paragraph D., "07-O-12379" is deleted, and in its place is inserted "07-O-12620".
4. On page 11 of the stipulation, paragraph F., "07-O-12379" is deleted, and in its place is inserted "07-O-13664".

Any objection to this modification order must be filed within 15 days of its service. If no timely objection is filed, the stipulation as modified remains approved, and a staff member of the State Bar Court is directed to transmit the record in this matter to the Supreme Court without further delay.


