



Teresa Straley is a patient under my care. She has been unable to prepare for and take the MPRE because of health challenges that have made it hard for her to function. She was in a weakened state from her colon removal surgery last year. She had three surgeries related to her colon and several follow up procedures due to leakage from her stoma. She had abscesses and antibiotic resistant staph infections as complications. She has also broken a finger in her left hand and has had surgery recently for it. She has had a back injury.

She is now taking the steps to get more support so that she will be less burdened by handling everything herself. Her living situation has been unstable as a result of her poor health. She was also without health insurance for a period of time but now has it. Therefore, she is more able to get the help she needs. Please make whatever accommodations possible for an extension of time so that she will be able to take the MPRE. She truly has been impaired, which has prevented her from functioning properly and attending to her affairs. She wants to comply and respects the State Bar process and the law. She plans to request accommodations for her hand and her ostomy bag and supplies, which she reports was not handled properly at the August test. Thank you for your consideration.
