On March 9, 2012, respondent Teresa Straley filed a motion seeking relief from or an extension of time to pay disciplinary costs and an extension of time to provide proof of passage of the MPRE and proof of completion of Ethics School. On March 19, 2012, the Office of the Chief Trial Counsel of the State Bar of California, by Assistant Chief Trial Counsel Dane C. Dauphine, filed opposition to the portion of the motion seeking relief from or an extension of time to pay disciplinary costs. On March 21, 2012, the Office of Probation of the State Bar of California by Supervising Attorney Terrie Goldade, filed a non-opposition response to the remaining portions of the motion.

The court has considered the papers filed in this matter and concludes that **GOOD CAUSE APPEARING THEREFOR**, the portion of the motion seeking an extension of time to provide proof of passage of the MPRE and proof of completion of Ethics School is **GRANTED**. The time within which respondent must provide proof of completion of Ethics School is extended to **September 2, 2012**. The time within which respondent must provide proof of passage of the MPRE is extended to **September 29, 2012**.



For the reasons set forth in the response filed by the Office of the Chief Trial Counsel, the portion of the motion seeking relief from or an extension of time to pay disciplinary costs is **DENIED**.
