On August 12, 2008, the State Bar of California, Office of the Chief Trial Counsel (State Bar) filed an opposition to respondent's motion.



The court therefore **GRANTS** respondent's motion to set aside his default, and respondent's default is ordered set aside. The court further orders respondent's inactive enrollment pursuant to Business and Professions Code section 6007, subdivision (e) terminated upon the filing of this order. The submission date of this matter is vacated.



The court further orders respondent to file a response to the Notice of Disciplinary Charges within seven (7) days of service of this order. The response must be verified and must set forth with specificity respondent's asserted defenses.
