## In the Matter of NATHAN JOSEPH SHERIDAN

a Member of the State Bar of California

On April 13, 2010, we issued an order to show cause why Nathan Joseph Sheridan, State Bar Number 208940, should not be placed on interim suspension as a result of his misdemeanor convictions of violating Penal Code sections 484, subdivision (a)/488 (petty theft) and 459/460, subdivision (b) (commercial burglary), crimes involving moral turpitude. The parties filed their responses.

Under the authority of rule 9.10(a), California Rules of Court, it is ordered that Nathan Joseph Sheridan be suspended from the practice of law effective May 28, 2010, pending final disposition of this proceeding. (Bus. & Prof. Code, § 6102.) It is also ordered that Sheridan comply with rule 9.20, California Rules of Court, and perform the acts specified in subdivisions (a) and (c) of that rule within 30 and 40 days, respectively, after the effective date of this suspension.

As the judgment of conviction is final, this case is referred to the hearing department for a hearing and decision recommending the discipline to be imposed.
