

Since respondent Jeanne Marie Rowzee, State Bar Number 141784, has been convicted of violating Title 18 United States Code section 371 (conspiracy to commit wire fraud), a felony involving moral turpitude, and Title 15 United States Code sections 78j(b) and 78ff (securities fraud), a felony, it is ordered pursuant to Business and Professions Code section 6102 that respondent be suspended from the practice of law effective September 21, 2012, pending final disposition of this proceeding. (Cal. Rules of Court, rule 9.10(a).) It is further ordered that respondent comply with California Rules of Court, rule 9.20, and perform the acts specified in subdivisions (a) and (c) of that rule within 30 and 40 days, respectively, after the effective date of this suspension.


