ORDER RE RESPONDENT'S MOTION TO EXTEND TIME TO PASS THE MPRE AND COMPLETE ETHICS SCHOOL

In March 2011, respondent **Elizabeth Karnazes** filed a motion for extension of time to take and pass the Multistate Professional Responsibility Examination ("MPRE") and complete the State Bar's Ethics School ("motion for extension").<sup>1</sup> Based on respondent's health and personal issues, the motion for extension requested an extension of time to March 4, 2012.

On March 11, 2011, the Office of Probation of the State Bar of California ("Office of Probation") filed a response. In its response, the Office of Probation did not object to an extension of time for respondent to take and pass the MPRE and complete Ethics School, but requested a shorter period of extension.

Good cause having been shown, respondent's motion for extension of time within which she must prove passage of the MPRE and completion of the State Bar's Ethics School to the Office of Probation is **GRANTED**. Respondent is **ORDERED** to provide proof of passage of

the MPRE and completion of the State Bar's Ethics School to the Office of Probation on or before March 4, 2012.<sup>2</sup>
