- 1. 664/288.2, subdivision (b) (attempt to send harmful matter with intent to seduce minor), a felony which involves moral turpitude,
- 2. 664/288, subdivision (a) (attempted lewd act upon a child), a felony which involves moral turpitude,
- 3. 311.11, subdivision (a) (possession of child pornography), a felony that may or may not involve moral turpitude,
- 4. 664/288.3, subdivision (a) (attempted contact with minor with intent to kidnap or commit sexual offense), a felony, and
- 5. 288.4, subdivision (a)(1) (contact of minor with intent to engage in sexual offense), a misdemeanor.¹

It is ordered pursuant to Business and Professions Code section 6102 that Cohn be suspended from the practice of law effective March 9, 2011, pending final disposition of this proceeding. (Cal. Rules of Court, rule 9.10(a).) It is further ordered that Cohn comply with California Rules of Court, rule 9.20, and perform the acts specified in subdivisions (a) and (c) of that rule within 30 and 40 days, respectively, after the effective date of this suspension.
