On December 6, 2012, respondent **Earl Wayne Husted** filed a motion seeking an extension of time to pay disciplinary costs associated with California Supreme Court Case Nos. S175102 and S196225 (“Motion for Relief”). Respondent’s motion was based on financial hardship. On December 11, 2012, Senior Trial Counsel Brooke Shafer, of the Office of the Chief Trial Counsel of the State Bar of California (“State Bar”) filed its opposition.

After consideration of the parties’ moving papers, the court **GRANTS** the motion, good cause having been shown. The court orders that respondent’s time to pay the disciplinary costs associated with Supreme Court Case Nos. S175102 and S196225 be extended and that one-third of said costs is to be paid with respondent’s annual State Bar membership fees for the years

2013, 2014, and 2015. Respondent is further instructed to contact State Bar's Membership Records to determine the exact fees to be paid in 2103¹; 2014; and 2015.

The court further ORDERS that, if respondent fails to pay any installment of disciplinary costs within the time provided herein or as may be modified by the State Bar Court pursuant to Business and Professions Code section 6086.10, subdivision (c), the remaining balance of the costs is due and payable immediately unless relief has been granted under the Rules of Procedure of the State Bar of California (Rules Proc. of State Bar, rule 286). The payment of costs remains enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.

IT IS SO ORDERED.


