On the court's own motion, the time for respondent **Frederick Hazlitt Brennan** to pay disciplinary costs in the above entitled matter is modified as follows:

The costs must be paid with his membership fees for the year 2012. If Frederick Hazlitt Brennan fails to pay the costs as described above, or as may be modified by the State Bar Court, the remaining balance is due and payable immediately.

Accordingly, this modification order re disciplinary costs is hereby effective, nunc pro tunc, as of **January 5, 2011**, so that respondent's last day of suspension should have been February 4, 2011, as originally ordered by the Supreme Court in case No. S186623, filed December 6, 2010. In the interest of justice, the court finds that it is just and proper to terminate respondent's suspension at the conclusion of his 30-day disciplinary suspension.


