On January 31, 2012, petitioner **Frederick Hazlitt Brennan** filed a brief seeking an extension of time to pay the remainder of the disciplinary costs owed in the above-listed matter. Petitioner's motion was based on financial hardship. On February 21, 2012, the Office of the Chief Trial Counsel of the State Bar of California filed an opposition to the motion.

After consideration of the parties' moving papers, petitioner's motion for extension of time to comply with the order to pay disciplinary costs is **GRANTED**. The court orders that petitioner's time to pay the remaining disciplinary costs associated with case no. 08-O-13723 be extended and that the costs are to be paid with petitioner's annual State Bar membership fees for the year 2013. The payment of costs remains enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.<sup>1</sup>
