Since respondent **THOMAS J. HASTERT, State Bar Number 143101**, has been convicted of violating Penal Code section 487 and 506, felonies involving moral turpitude, under the authority of rule 9.10(a), California Rules of Court, it is ordered pursuant to Business and Professions Code section 6102 that he be suspended from the practice of law effective July 10, 2009, pending final disposition of this proceeding. It is further ordered that he comply with rule 9.20, California Rules of Court, and perform the acts specified in subdivisions (a) and (c) of that rule within 30 and 40 days, respectively, after the effective date of this suspension.

Thomas J. Hastert was also convicted of violating Corporations Code sections 25110 and 25540, misdemeanors which may or may not involve moral turpitude and Corporations Code section 25401, a misdemeanor. Thomas J. Hastert shall have ten days after service of this order to file a response to the State Bar's motion regarding the moral turpitude classification of his violation of Corporations Code section 25401.


