We have received evidence that respondent David Kiernan Replogle, State Bar Number 77875, has been convicted of felony violations of the following Penal Code sections:


1. 187, subdivision (a) (first degree murder)¹
2. 182, subdivision (a)(1) (conspiracy). Specifically, respondent conspired to commit the following crimes:
 - a. Murder in the first degree (§ 187)
 - b. Identity Theft (§ 530.5, subd. (a))
 - c. Procuring and Offering a False or Forged Instrument (§ 115)
 - d. Forgery (§ 470, subd. (a))
 - e. Grand Theft (§ 487)
3. 459 (first degree burglary) (two counts)
4. 459 (second degree burglary)
5. 487, subdivision (a) (grand theft)
6. 530.5, subdivision (a) (identity theft)
7. 115 (procure or offer a false or forged instrument)
8. 496, subdivision (a) (receiving stolen property)

Because these crimes are felonies and involve moral turpitude, it is ordered pursuant to Business and Professions Code section 6102 that respondent be suspended from the practice of law effective April 15, 2011, pending final disposition of this proceeding.

¹ The jury also found that the murder involved "special circumstances" pursuant to Penal Code section 190.2, subdivision (a)(1): it was intentional and carried out for financial gain.



(Cal. Rules of Court, rule 9.10(a).) It is further ordered that respondent comply with California Rules of Court, rule 9.20, and perform the acts specified in subdivisions (a) and (c) of that rule within 30 and 40 days, respectively, after the effective date of this suspension.


