Crime(s) of which convicted and classification(s): Violation of Title 26 United States Code § 7201 (Tax Evasion), one count, a felony which this Court has classified as a crime for which probable cause exists to believe that it involves moral turpitude as in *In re Hallinan* (1954) 43 Cal.2d 243, but which the State Bar believes involves moral turpitude per se pursuant to *Elwert v. United States* (9th Cir. 1956) 231 F.2d 928, 932-933 [ruling that federal tax evasion conviction requires proof of specific intent to defraud the United States], *Tsueng Chu v. United States* (9th Cir. 1957) 247 F.2d 929, 936, cert. denied, 355 U.S. 892 [declining to follow *Hallinan* and finding that tax evasion involved moral turpitude and required specific intent to defraud the government], *Carty v. Ashcroft* (9th Cir. 2005) 395 F.3d 1081, 1085 [noting that the *Hallinan* Court noted that tax evasion did not constitute moral turpitude for immigration purposes, which was true then, but which is no longer true in the Ninth Circuit], *Kirby v. Alcoholic Beverage Control Appeals Board* (1969) 270 Cal.App.2d 535 [finding tax evasion involves moral turpitude], and *Windham v. Board of Medical Quality Assurance* (1980) 104 Cal.App.3d 461, 469 [finding that a doctor's conviction for tax evasion under 26 United States Code § 7201 necessarily involved moral turpitude].
