On April 22, 2013, respondent Jon Eric Gelb filed a motion for an extension of time to pay discipline costs or, in the alternative, for relief from paying the costs in whole. The Office of Probation does not oppose the extension of time but does oppose relief in whole.

Respondent filed his motion in case number 12-PM-11647. The costs in that case were imposed by Supreme Court order filed September 25, 2012, which ordered the costs be paid with respondent's membership fees for the years 2014 and 2015. Those costs are not yet due. However, the costs imposed in case number 09-C-16768 were imposed by Supreme Court order filed August 25, 2010, which ordered the costs in that case be paid with respondent's membership fees for the years 2011, 2012, and 2013. These costs are currently due. The court therefore deems respondent's present motion to be requesting relief in whole or in part from the costs imposed in case number 09-C-16768.


Having carefully considered the motion and response, the court concludes that good cause is shown to extend the time for payment of the costs, but not to relieve respondent in whole from paying them. Accordingly, the costs ordered in case number 09-C-16768 (S183870)



must be paid on or before September 3, 2013. The payment of the costs remains enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.

IT IS SO ORDERED.


