On January 9, 2012, respondent Marc Alan Fisher filed a motion to extend the time period in which he must provide proof of passage of the Multistate Professional Responsibility Examination (MPRE) until after the release of the March 17, 2012 MPRE results. Respondent also requests that he be given an extension to attend the State Bar Ethics School class on March 15, 2012, so that he may fulfill his mandatory remedial ethics education requirement.

Additionally, respondent requests that the court order that in the event that he does not pass the March 2012 MPRE, he will be allowed to take the August 10, 2012 MPRE.

On January 12, 2012, the State Bar of California, Office of Probation filed a response of non-opposition to respondent's request for an extension of time to provide proof of passage of the March 17, 2012 MPRE and his request to attend the March 15, 2012 Ethics School course.

GOOD CAUSE HAVING BEEN SHOWN, the court **GRANTS** respondent's request to take the March 17, 2012 MPRE and the March 15 2012 Ethics School course. The time

within which respondent must provide proof of passage of the MPRE and proof of completion of Ethics School is extended to May 11, 2012.

Respondent's request that the court at this time order that he be allowed to take the August 2012 Multistate Professional Responsibility Examination, as a "back up" is **DENIED WITHOUT PREJUDICE**. After receiving the results of the March 17, 2012 MPRE, respondent may move the court to allow him to take the August 2012 MPRE, upon a showing of good cause.

IT IS SO ORDERED.
