On September 24, 2010, respondent and the Office of the Chief Trial Counsel of the State Bar of California entered into a stipulation in this matter, which was signed by the court and ordered by the Supreme Court. Commencing at page 14, the stipulation set deadlines for restitution payments. On September 6, 2011, respondent filed a motion seeking an extension of time to pay the restitution payments. On September 15, 2011, the Office of Probation filed opposition to the requested extensions.


