On April 23, 2014, a motion was filed by Petitioner, seeking a modification of the condition of probation that she take and pass the State Bar's Ethics School within one year of the commencement of her probation. While that calendar deadline is March 26, 2015, the last program conducted by the State Bar before that deadline is February 19, 2015. Respondent, who is a resident of Arizona and not able to make the February program, requests that the deadline be extended or that she be allowed to fulfill her obligation by attending six (6) hours of CLE, including a comparable ethics program sponsored by the State Bar of Arizona.

On January 16, 2015, the Office of Probation filed a response to the motion, indicating that it had no opposition to the request.

GOOD CAUSE APPEARING, Respondent's motion is granted as follows: The deadline for Respondent to take and present proof of passage of the State Bar's Ethics School is extended to September 25, 2015.

Further, as an alternative to taking and presenting proof of passage of the California State Bar's Ethics School, Respondent may take and present proof of her completion of six (6) hours of Continuing Legal Education in the areas of Ethics and Substance Abuse. Such hours of CLE must include her successful completion of the Arizona State Bar program on professionalism, referred to by the parties in their respective briefs. In the event Respondent accepts this alternative manner of compliance, the same deadline of September 25, 2015, will apply.
