## DECLARATION OF KAREN A. CORBIN

I, KAREN A. CORBIN DECLARE THAT:

I am the Respondent and attorney, in pro per for Respondent.

I am currently under the care of Ralph D. Mozingo, D. O., for pain management. For the last two (2) months, I have been bedridden with incapacitating pain in my right shoulder and mid back. The MRI states that my shoulder has several tears in the muscles, that the shoulder contains materials from the body which have broken loose and the joint is damaged possibly requiring surgery. I have an appointment to see a shoulder specialist. I am going to Dr. Mozingo on January 10<sup>th</sup> to arrange for shots in my back to reduce the pain and lower the swelling in the back.

On January 6, 2012 I went to my second physical therapist appointment. I have had to miss several of those

appointments due to incapacity. My legs have not been working properly and the cause is unknown. I previously have taken the bus to my appointments, but lately I have had to cancel numerous appointments in addition to physical therapy, because I have not been steady enough on my feet to take the bus and cannot afford other modes of transport. A friend gave me a ride to <sup>the</sup> ~~this~~ appointment ~~today~~ <sup>on January 3, 2012</sup>. Presently, I am unable to walk to the grocery store (which is several blocks away), do laundry and have extreme difficulty preparing meals due to muscle shaking in my hands.

Service of the Answer was to be by personal delivery on January 13, 2012 by Mary Hunter who is my driver to court. Hence, I apologize for the numerous hand written changes to the proof of service. I am unable physically to retype that document because I hardly have the use of my hands right now and must get this Answer filed. During this last two (2)-month period I have

had trouble focusing due to the high pain level, which has caused me to seek specialists for help. Today I <sup>WAS</sup> unable to WALK FOR SEVERAL MINUTES.
