

Since respondent Michael Theodore Pines, State Bar Number 77771, has been convicted of violating Penal Code sections 459, 460, subdivision (b) and 664, subdivision (b) (attempted second degree burglary), a misdemeanor involving moral turpitude, it is ordered pursuant to Business and Professions Code section 6102 that Pines be suspended from the practice of law effective December 30, 2011, pending final disposition of this proceeding.<sup>1</sup> (Cal. Rules of Court, rule 9.10(a).) It is further ordered that Pines comply with California Rules of Court, rule 9.20, and perform the acts specified in subdivisions (a) and (c) of that rule within 30 and 40 days, respectively, after the effective date of this suspension.


