

On December 14, 2011, respondent Eric William Scholz filed a second revised motion seeking relief from or extension of time to pay disciplinary costs. With this motion respondent submitted financial information previously omitted from his earlier motions for relief filed on September 19, 2011 and October 17, 2011. On December 16, 2011, the Office of the Chief Trial Counsel of the State Bar of California, by Deputy Trial Counsel Margaret P. Warren, filed opposition, in part, to the motion.

**GOOD CAUSE APPEARING THEREFOR**, the motion for an extension of time to pay disciplinary costs is **GRANTED**. Respondent is ordered to pay the outstanding disciplinary costs in monthly payments of \$50.00 per month, payable on the 15<sup>th</sup> of each month, commencing January 15, 2012, until the obligation is satisfied. In the event respondent fails to make any installment payment or submits any installment payment more than 15 days after the due date without the prior written approval of the State Bar's Office of Probation, the unpaid balance of the discipline costs shall become immediately due and the State Bar may obtain and seek to collect a judgment for that unpaid balance.


