On May 2, 2012, respondent Jordan Richard Morgenstern, by counsel William A. Munoz, filed a motion to extend his probation until October 31, 2012¹, in order to take and pass the Multistate Professional Responsibility Examination (MPRE) and to complete Ethics School.

On May 7, 2012, the Office of Probation, by Terrie Goldade, filed opposition thereto, to which respondent replied on May 10, 2012.

Having considered the parties' contentions and good cause appearing, the court GRANTS respondent's motion as consistent with the objectives of his disciplinary probation. (Rule 5.300(B), Rules Proc. of State Bar.) Respondent mistakenly believed that he had until August 2012 to complete the MPRE and Ethics School and to provide proof thereof to the Office of Probation. He has registered for the June 21, 2012 session of Ethics School and for the August

10, 2012 session of the MPRE. Accordingly, IT IS ORDERED that the time in which respondent must provide satisfactory proof of the successful completion of the MPRE and Ethics School to the Office of Probation be extended until October 31, 2012. It is not necessary to extend respondent's probation as the two-year probation ordered by the Supreme Court in S190328, effective on May 14, 2011, does not expire until 2013.

All other terms and conditions remain the same.
