On October 28, 2013, respondent David Michael Spieker (respondent) filed a motion for relief from payment of restitution or extension of time to pay, and response to notice of intention to pay received from the Client Security Fund. The grounds for extension included respondent's financial condition and delay in receipt of payment from his substitute teaching work. On October 31, 2013, the Office of Probation of the State Bar of California (Office of Probation), opposed the motion on the ground that respondent's family's take home pay is sufficient to pay the specified restitution.


After considering respondent's motion and the Office of Probation's response thereto, and good cause having been shown, the court grants respondent's motion. The court makes the following orders:

1. Respondent's probation is extended by four months to October 13, 2015.

2. Respondent is relieved from the condition of probation of making the monthly restitution payments to Soledad Ibarra Nunez, Eberardo Perez, Maria Ramos Gonzalez, and Roberto Hernandez scheduled for September, October, November and December of 2013, but must resume the monthly restitution payments to Soledad Ibarra Nunez, Eberardo Perez, Maria Ramos Gonzalez, and Roberto Hernandez, in January 2014;
3. Respondent must provide satisfactory proof of payment to the Office of Probation with each quarterly probation report, or as otherwise directed by the Office of Probation;
4. No later than 30 days prior to the expiration of the period of probation, respondent must make any necessary final payment(s) in order to complete the payment of the restitution, including interest, in full; and
5. If respondent fails to pay any of the installments, as extended by this order, the remaining balance is due and payable immediately.
