On May 10, 2013, Respondent filed a motion seeking partial relief from the Supreme Court's prior order assessing costs in this matter. In support of his motion, Respondent provided a financial statement showing his present financial inability to pay the required costs. Respondent asks that his current obligation to pay costs in 2013 be deferred so that he may continue to practice in order to generate the income required to pay the costs.

On May 17, 2013, the State Bar filed an opposition to the motion, arguing, inter alia, that Respondent's motion should be denied because it wasn't filed "as soon as practicable."

Under the original court order, Respondent is obligated to half of the assessed costs with his membership dues in 2013 and the other half with his membership dues in 2014. GOOD CAUSE having been shown, Respondent's obligation to pay one-half of the costs in this matter with his dues in 2013 is modified and extended for one year from the original due date. In other words, Respondent's obligation to pay all costs in this case will be due with his membership dues for 2014.

**IT IS SO ORDERED.**


