On December 12, 2016, David Malveaux (Respondent) filed a motion seeking complete and/or partial relief from the order assessing costs in this matter. The amount of such costs was stated to be \$12,757. In support of that motion, Respondent attached a financial statement and declaration stating that he was receiving SSI/SSP supplemental payments and demonstrating his present financial inability to pay such costs.

On December 20, 2016, the State Bar filed a statement opposing the granting of complete relief regarding Respondent's obligation to pay costs but not opposing the granting of a two-year installment program by which such costs are to be paid.

On December 22, 2016, this court issued an order denying Respondent's request for complete cost relief, but allowing costs to be paid in two installments, with one-half of the present balance to be paid by Respondent on or before each of the deadlines for payment of membership fees for the years 2018 and 2019.

On March 22, 2018, Respondent filed a new motion seeking complete and/or partial relief from the order assessing costs in this matter. The amount of such costs is once again stated to be \$12,757. In support of that motion, Respondent attached a financial statement and declaration stating that he is still receiving SSI/SSP supplemental payments and demonstrating his present financial inability to pay such costs.

On April 3, 2018, the State Bar filed a statement opposing the granting of complete relief regarding Respondent's obligation to pay costs but not opposing the granting of a delayed two-year installment program by which such costs are to be paid.

GOOD CAUSE having been shown, Respondent's obligation to pay costs is hereby modified and extended as follows: the sum of the disciplinary costs currently still owed (Present Balance) will be due and payable in two installments, with one-half of the Present Balance to be paid by Respondent on or before each of the deadlines for payment of membership fees for the years 2019 and 2020. If Respondent fails to pay either of the above installment payments more than 10 days after its due date without the prior written approval of the State Bar or the State Bar Court, the remaining unpaid balance of the costs will be due immediately and be enforceable both as provided in Business and Professions Code section 6140.7 and as a money judgment.



Respondent's request for complete relief from his obligation to pay costs is DENIED.

IT IS SO ORDERED.
